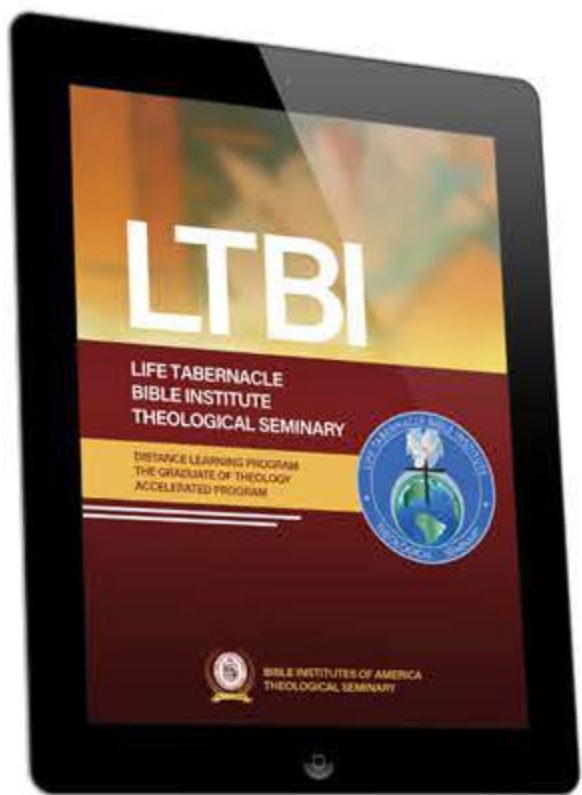

## REFUND POLICY

Application and registration fees are non-refundable. course units can be returned to Word Of Life Tabernacle Church, c/o LTBITS, P.O. Box 25822, Fayetteville, NC 28314.

The amount of refund that students can receive if they withdraw from a paid class will be as follows:

- during 1st week of classes - 60 percent refunded.**
- during 2nd week of classes - 40 percent refunded.**
- during 3rd week of classes - 10 percent refunded.**

# CERTIFICATE PROGRAM

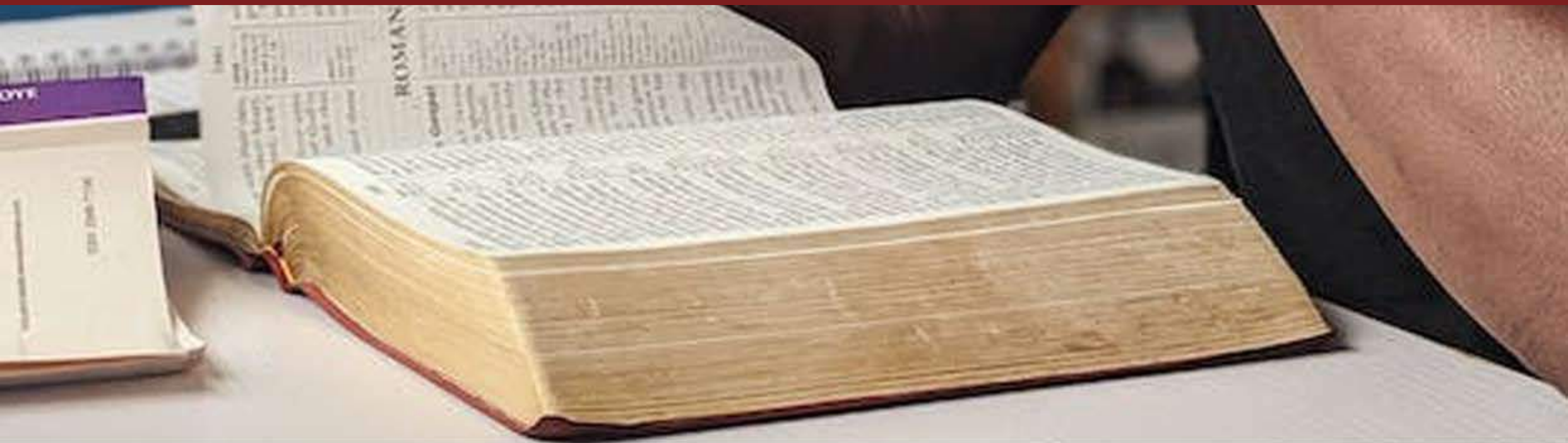
